ASCCC Fall Plenary OER/ZTC Resolutions

Passed

- o 3.04 Develop Statewide Recommendation for Definition of Low-Cost Course Materials
 - Resolved, That the Academic Senate for California Community Colleges work with the Student Senate for California Community Colleges and California Community Colleges Chancellor's Office to identify a recommended definition of "low-cost" to be considered for adoption throughout the California Community College system.

- o 3.05 Zero Means Zero Textbook Cost
 - Resolved, That the Academic Senate for California Community Colleges recognize open educational resources as the preferred and most sustainable mechanism for eliminating course costs but acknowledge that instances will arise in which eliminating costs is not possible;
 - Resolved, That the Academic Senate for California Community Colleges assert that while open educational resources can reduce or eliminate instructional materials and textbook costs, resources should be dedicated to convening discipline faculty to determine the most sustainable mechanisms for reducing the costs of course resources; and
 - Resolved, That the Academic Senate for California Community Colleges encourage the use of approaches that significantly reduce course resource costs such that course sections with a low-cost can obtain zero-textbook-cost status by virtue of the cost being absorbed by the college, district, or the state.

 - Resolved, That the Academic Senate for California Community Colleges work with our faculty colleagues in the California State University and University of California, through the Intersegmental Council of Academic Senates (ICAS) and other practitioner groups, to explore options, including legislation, to support libraries in their ability to provide electronic access to required course materials that students need to succeed in their courses.

IDEA OF THE MONTH

DEI in OER

As a college, as a district, and in general, we educators are putting more emphasis on the importance of diversity, equity, and inclusion, in every aspect of our courses. It only makes sense that our course materials are a big focus.

In the Spring 2022 semester, there will be a series of DEI-themed workshops put on by the ZTC Teams of each of our campuses, starting with a January Flex Day discussion on how DEI fits into our course materials, and how OER materials can help you increase representation and inclusion. We'll have lessons that the Skyline and Cañada teams learned in RLOE this past fall, and student perspectives of why representation and inclusion matter in our course materials.

We'll be following up with more opportunities in March during Open Education Week (7–11 March) and our April Flex Day. There are other conferences and workshops being announced constantly; ask Sarah and Diana for more information!

To Strategically Go Where Cañada Has Not Gone Before!

In a recent Planning and Budgeting Council meeting, the <u>Free College Initiative Budget</u> was laid out, which included funding for OER/ZTC. This is the money that was budgeted in the 2021-2022 SMCCCD Budget, with \$1.25M being set aside for OER/ZTC efforts in the District.

The result is that there is money to support the <u>ZTC Adopter Program</u>, which will come back for late Spring 2022. We also got further support for the ZTC Coordinator, which will help in all of the work to be done with the upcoming endeavors. All of this support is wonderful...but our wish list is long!

In October/November, Sarah Harmon and Diana Tedone–Goldstone attended the <u>Regional Leaders in Open Education</u>'s first cohort. The final project for the program was to come up with an open education strategic plan, focusing both on OER/ZTC adoptions and open pedagogy practices. That strategic plan is in the works–we'll be continuing to work on it in the 25 January meeting–and it helps us plan out the next 2 semesters through the next few years. This helps us build out our wish list. While we are still working on our full list of needs, we have a singular goal: to make it so that 75% or more of course materials are satisfied by ZTC sources. This includes the use of OER, library resources, public access materials, and more. We want to accomplish this goal by 2030–that's a hefty goal!

What will it take to get to that goal? Simple: Support. Not just the obvious support, the money and release time needed to coordinate and work with faculty. It also requires continued support of faculty who revisit their courses, look for new and innovative ways to bring course materials to their students, and to do so using methods that are free for students. It means supporting faculty-and entire departments!--who want to do this work, by giving them the tools, the time to think and reflect, and the guidance along the way. We need increased library resources-not just for Cañada, but district-wide-and access to a wide variety of materials. We need workshops to help faculty adopt, remix, and author...and then other ways to help staff and students learn about these resources. We need accessibility folks to help us...because their expertise is in such high demand!

We are not alone in this planning; The Skyline ZTC Team also completed the same program as Sarah and Diana, and their folks (Ame Maloney and Bianca Rowden–Quince) are working on their plan now. The CSM Team will be completing the program later next semester, too. And the entire Textbook Affordability Solutions Workgroup has been communicating with the District to implement as many strategies as possible on a district–wide level.

As the TAS finishes the strategic plan, we'll be taking this to the Academic Senate and other participatory governance groups, to get as much feedback as possible. We want to hear from youwhat do you need to make the switch to ZTC?

Focus Topic: To-Do List for Winter Break



We're almost there! Time to finish up fall grading, kick back for a bit...and work on our spring courses?

It's true, we all end up thinking about how we want to tool (or retool) our spring courses while drinking eggnog, eating latke, or just loafing around in our comfy slippers as we watch the calendar flip from one year to the next. We set up our Canvas shells, and we think about... do we really want to give this YouTube video to our students? Or should we change it to that one? Maybe instead of this article, we switch things up and give them that one?

As you go through your list and check it twice, finding out if everything looks just right, keep in mind the following OER/ZTC checklist:

- If you're using an OER text, has the URL changed?
- If you're using something that's on LibreTexts, Pressbooks, or another repository, have you downloaded the resource to your Canvas course shell? And is it set up right (probably in your modules)?
- If you're using a series of articles that you found in our library databases, have you given the students Permalinks or similar URLs?
- If you're using a series of public access websites, are the links still valid?

Finally, for all of your materials: are they fully accessible? Not just in the pay-sense ('Are they free/open source?'), but in such a way that all of our students are able to use our course materials, regardless of their abilities.

Other OER News

- California funding for ZTC will be announced during finals week, with more news on this in January. Expect a couple of grant opportunities...start thinking big, folks!
- Open Oregon has been curating <u>a series of resources that are focused on DEI</u>.
 Most resources are for humanities courses, but there are many options for multiple disciplines. Check it out!
- In collaboration with the Michelson 20MM Foundation Spark Grants program, ISKME is conducting a landscape study and gap analysis, ZTCs for High Wage, High Demand Fields: Bay Area Landscape Study. As state funding for OER development continues, the project will support Bay Area community colleges in their ZTC decision making through a regional network around shared data and evidence to support OER in high wage, high demand fields. This work will also inform those seeking to conduct a gap analysis specific to the local economies of other regions throughout the state.
- Our colleagues Una Daly at CCC-OER and Judith Sebasta at OpenTex published an article for the Community College Daily, a publication of the American Association of Community Colleges. Their article, titled "Time for OER," looks at the reasons why all community colleges need to incorporate OER and other ZTC measures in order to properly make college affordable for all students. 
Latest OER Publications
