# The Prioritization Proposal (DRAFT)

**PRE-RANKING WORK:** Local decisions (not included for PBC prioritization):

- Resources that can be funded locally, are under \$500, are related to health & safety.

**FIRST RANK:** Program OR Area (sequential order)

**SECOND RANK:** Division (sequential order), use updated rubric and spreadsheet

- Administrative Programs
- Academic Support, Learning & Technology
- Business, Design & Workforce
- Counseling
- Humanities & Social Sciences
- Kinesiology, Athletics & Dance
- Science & Technology
- Student Services

# The Prioritization Proposal (DRAFT)

**THIRD RANK:** Planning & Budgeting Council (sequential order)

Critical Questions (to inform ranking):

- Contributes to closing the equity gap
- Contributes to supporting Latinx student success

Step 1: PBC shares draft prioritization (sequential order).

Step 2: Campus receives draft priority ranking.

Step 3: PBC invites Division leads to share program feedback or new info (related to critical questions).

Step 4: PBC confirm draft or (re)rank. Move recommended ranking to College President for review.
