## Colleagues,

This is the second of the three enrollment updates for this term. The dates for the three updates are: the End of the First Day of Classes (August 17, 2015), the Last Day to Add/Drop (August 28, 2015) and the Official Census Day (September 8, 2015). The Board of Trustees receives formal reports from my office on the data from the Official Census Day. Please note there is a two-week delay in certifying the Official Census Day data.

Special Notice: To make our productivity reports more accurate, effective fall 2010, contract courses (attendance method = OC) are excluded from Enrollment, FTES, WSCH, Load and Sections. Data from all prior terms still include these courses, however, the impact of this change is expected to be small. Starting fall 2011, we have added "internet" to reflect distance education enrollments.
