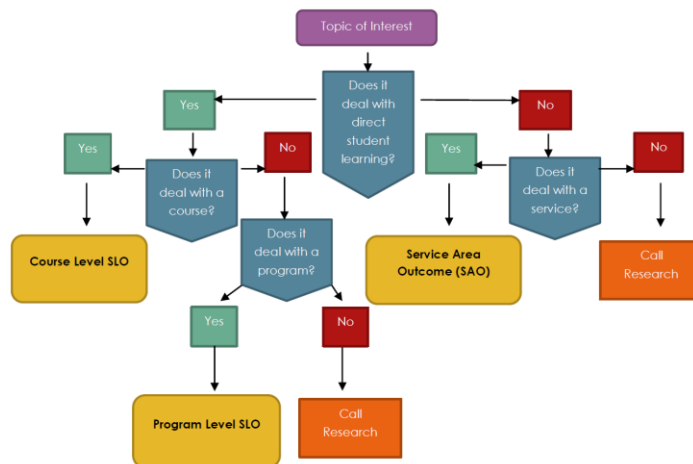

I. Assessment Manual

Cañada College’s commitment to providing exceptional educational opportunities for its community is demonstrated by its robust processes of assessment of student learning and Program Review. Both processes, which are mandated by the ACCJC, are integrated into the culture of the college. As a student-centered institution, the college is engaged in assessment, evaluation and reflection in order to gauge the effectiveness at an institutional, service area, program, and course level.

SSPC reviewed and approved the Assessment Manual to move forward to Planning & Budgeting Council for final approval.



II. College Recommendation Report

a. College Recommendation #1
